## **USISTD Constitution and Bylaws:**

### Article VI Chapters

A Chapter may be formed where at least five (5) members or Adjunct Members in good standing join and it meets the conditions required by the National Committee.

1. Chapter Committees shall be comprised of three (3) members elected from among the Chapter membership.
2. Candidates for election to Chapter Committees must be current and in good standing with respect to their dues
3. Chapter Committee terms shall be for one (1) year and elections for the new term shall be held during the late fall of the year. Chapter terms will be from January 1- Dec 31 annually.
4. Once elected, the Chapter Committee shall select its own officers by vote at their first meeting. Officers shall consist of Chairman, Secretary, and Treasurer, one of whom shall be a full Member of the Society.
5. The officers shall provide the National Committee with minutes of all Chapter meetings and with quarterly financial statements.
6. (a) Chapter members may include USISTD Members, Adjunct Members, and Auxiliary Members. (b) Adjunct Members are dancers that have successfully completed a USISTD Medal Test. (c) Auxiliary members are other dance enthusiasts, supporters, and professionals that are not yet Members of the Society
7. Failure to comply with these requirements will result in intervention by the National Committee and, should the National Committee deem such action appropriate, may ultimately lead to the dissolution of the Chapter. In the case of the dissolution of any Chapter, all financial records, funds, checkbooks, bank accounts, electronic bank records, and properties if any, shall be forwarded to the National Committee within 45 days.
